This Decision enters into force on the day of its adoption.

Reasoning

At its 26th session, held on 28 June 2018, the Senate of the University of Banja Luka issued the Decision on Appointing Members of the Working Group for the Implementation of the Charter and Code of the University of Banja Luka No 02/04-3.1780-7/18 of 28 June 2018 and at the session of 27 February 2020 the Decision on Amendments to the Decision on Appointing Members of the Working Group for the Implementation of the Charter and Code of the University of Banja Luka, No 02/04-3.464-6.1/20.

At its 79th session, held on 28 April 2022, the Senate of the University of Banja Luka repealed the said Decision No 02/04-3.1780-7/18 of 28 June 2018 and Decision No 02/04-3.464-6.1/20 of 27 February 2020, and appointed new members of the Working Group for the Implementation of the Charter and Code of the University of Banja Luka.

In view of the above, it has been decided as in the enacting clause of this Decision.
